If this is the case, we may consider granting a special allowance to offset a portion of the water wasted, provided that the repair work was undertaken by a Licensed Plumber and the necessary certificate/s are completed and submitted to the Western Australian, Plumbers Licensing Board.

Please provide the **completed Leak Allowance Application** together with a **copy of the licensed plumber's invoice** within 7 days of the date of repair to the above address.

An allowance will NOT be considered for:

- hidden leaks and/or bursts on internal appliances, fixtures or fittings including air conditioners, dish washers, swimming pools, hot water systems, toilet cisterns, valves
- leaks on or due to internal or external taps
- situations where the leak is visible
- situations where the leak is not repaired by a licensed plumber
- situations where the internal plumbing is open ended (i.e. not connected to anything)
- leaks on mains reticulation (the manual isolation valve must be installed by a licensed plumber, if a leak is repaired at this point an allowance may be considered)
- plumbing that is not compliant with government regulations
- vacant or unattended premises

If you engage the services of a Licensed Plumber to check or make repairs to your internal service, the Water Corporation will not reimburse you for their cost.

Plumbers must hold a valid plumbing contractors license and be registered with the Western Australian, Plumbers Licensing Board. For more information, contact the Board or visit their website at www.plumbers.wa.gov.au
